- How to continue Athena with 3-4 members taking on management
- Focus on Athena as a Fundraiser for scholarships
- Get our AAUW Brand out to the community
- Build the Event with membership participation
- Set a potential goal of \$4,000 profit

Additional Athena Award Notes - Amy Shamroe, Event planner – via phone with Q/A with Board members:

- Amy has received positive feedback from winners and nominees
- Cherry Republic involvement next year is BIG; CONE Drive will help again; West Shore Bank must be approached near end of year start getting sponsors much earlier
- Eva Petoskey's statuette may arrive July, presentation possibly held in Peshawbetown; Do Press Release for Winners & next year's event (Thurs before Mother's Day is a good date)
- 100 in attendance, Could add 1 more Table but not too crammed; Kirkbride is a good location and price
- People would love to hear from the Winners; Amy, year before nominator spoke a little bit about each nominee; Laura Organizers could make a very short video clip of nominator's comments as a way to not go over, keep timing tight, also hear a bit from the Nominees
- Holly Bird Memorial Stone Holly (ba) was also awarded Sara Hardy recently, so giving breathing space to family; Amy S. will work with Holly's sister
- Lauren How many sponsors are reasonable for TC? Amy \$3,000 \$5,000 would be doable, considering this is a "pinched" economic time; In 8-10 years this could be a \$10,000 event; Amy knows 5 businesses that would sponsor right now
- Best Time to approach sponsors October (Honor Bank, West Shore Bank, 4Front, Cone Drive), with January after holidays for small businesses Intimi, My Secret Stash, Cherry

- Republic Have 1 person committed to be the "Asker", with polished Ask Amy can share details of how and what to provide approaches
- If Branch hires someone to get sponsorships, we should incent them by giving them 10-20% of sponsorships they procure.

- Report from Marlene/Scholarships Committee is in favor of increasing Scholarship amounts, but until our overall funding increases, this is holding as is
- NOTE: A Goal to pursue When we increase \$ to MVM Scholarship \$12,000 it will take the Endowment to \$50,000 and it will become self-sustaining
- NOTE: Every year Branch receives miscellaneous donations, for Memorials, etc. So there will be extra funds available for unseen expenses, but not included as REVENUE
