Athena Awards - Lauren Johnson

Difficulty finding people to lead 3 Groups - Sponsors, Event, Nominations; Bonnie Willings agreed to lead Publicity. Branch members are very busy, and/or don't understand Branch connection to Athena.

Susan Hughes spoke about the fact that Athena may not be our Mission. It is more Business focused rather than Education focused. And she stressed the need for an honest, verifiable selection process (numerically, not a consensus; juried means interviewing). The membership needs to give it 150% and we don't have that at this point, since we don't have leadership.

Further discussion followed:

- This year's event only made about \$2,000, which was barely enough for one scholarship.
- Athena may not be the only way or event to raise funds. What about a Scholarship fund-raising or Scholarship Bash to include Networking with other women.
- Athena's costs = \$1000 for the Athena license, \$645 for the trophy. What does corporation do with collected funds?

Amy moved that the Branch suspend the Athena Award Event at least until the 2027 program year. Darlene second. Motion was approved by all.

Additional discussion ensued focused on other fundraising ideas that would also include networking with women. Ideas from other branches were mentioned, and other ideas can be gleaned from National. The focus would be on our Mission, which is furthering education and equity for women and girls.

Amy moved that the Branch sponsor a fundraising event that aligns with the AAUW mission of raising funds for scholarships. Chris second. Motion was approved by all.

A brainstorm committee will be formed. Jean and Lauren will convene the group.

Events with NMC – Carol will connect with Alison Thornton, and Board could meet at NMC. Allison is interested in engaging more people at NMC to be involved with AAUW.
